2020 YEAR-END NOTE FROM THE DIRECTOR

We all have many stories to share about 2020. We have lost, found, grieved, worried, inspired, cried and laughed. All our experiences have been, in every sense of the word, peculiar. If we look up "peculiar" in a dictionary, it gives us three other terms that may summarize 2020: unexpected, baffling, and extraordinary.

This pandemic is caused by a virus whose transmission and impact were unexpected. The Indonesian government responded to the pandemic in a way that was (and still is) baffling. And yet we conducted ourselves in an extraordinary manner. Everything that the pandemic brought about was entirely new for most of us. Nevertheless, we are still moving forward. I am therefore writing this note as an encouragement to not let the lessons we have learned from 2020 go to waste.


Science is still our best bet, but only if we listen to it.

Sometime in September 2019, I was listening to Sam Harris's podcast Making Sense. The episode was called "The Plague Years," in which he interviewed Matt McCarthy, the author of Superbugs: The Race to Stop an Epidemic. They talked about everything we are facing in this moment. A couple of years earlier, I had attended classes that discussed case studies on the ongoing Ebola outbreak. I was lucky to have been made aware of such dangers beforehand, and that therefore this pandemic did not come to me as a shock, but it was even more fortunate that nobody on our team was a denier of the severity of its impact. Everyone here was and still is open-minded. Our willingness to listen to the science and observe the evidence has enabled us to quickly adjust our ways of working since March 16th and to prepare everyone for the long haul. Shortly after the office was closed, we knew this would be a marathon, not a sprint.

Team, thank you for your continuous commitment to examining the facts and to interrogating our own interpretations of these facts. Thank you for your patience, because knowledge evolves gradually, and full comprehension develops only slowly from a series of inconclusive results.

When the situation baffles us, adaptation is our only source of hope.

When we realized that this pandemic was not going to go away quickly (despite what the government claimed at the time), we set up a system to make sure everyone in our team was safe and able to mitigate the pandemic's consequences. Our management was very aware that every decision they made took another option away. We shifted to a fully coordinated remote working plan, which was in our best interest as well as for the people around us, but also beneficial in terms of the response to the pandemic itself. We had already been operating according to a partial remote working plan for years, because we measure our performance by the quality of outputs and the adherence to deadlines rather than physical presence. But we also knew that going to the office provides structure, purpose, and even an occasional escape for some people. The management's responsibility was to support the team in staying healthy, flexible, and virtually connected. The success of this transition depended on a number of difficult decisions that were necessary to ensure the practical continuation of our work in the future.



Organizing is a survival skill.

This year we learned that we should never take organization skills for granted not just in our work but also in our personal lives. First, we make plans. We identify the problems, set our goals, and break down the various parts that need to be tackled. Second, we allocate our resources, be it time, money, technology, manpower, and the support from others. Third, we do our work in a disciplined manner and evaluate it constantly.

Team, thank you for always striving for excellence through collaboration. For conceding our mistakes and shortcomings while not letting ourselves dwell on disappointment and guilt. For knowing when to act, schedule, delegate, and let go. For adjusting our targets and not being complacent. For exploring matters intellectually despite being first drawn to the subject emotionally, and vice versa. For being honest in recognizing our feelings. For being kind to others as well as ourselves.

Supported by our partners, this year we completed seven studies, finalized over a dozen reports, and reached over 2,000 people through our activities. We published three journal articles and submitted several manuscripts. We maintained our support for the implementation of a number of national strategies and for the development of new ones. We assessed how to sustain meaningful and ethical research as well as advocacy for children and vulnerable groups in a time when direct contact may threaten the people we want to help. We will continue to persevere in these efforts. In addition, we contributed to the pandemic response. Through collaborative work, we developed guidelines for identifying invisible populations who need to be registered in order to receive support. We assisted 12 districts in four provinces as well as village officers in providing access to vulnerable individuals in need of social assistance during the pandemic. We trained health and community volunteers, and we developed a set of policy recommendations for responding to as well as mitigating the impact of COVID-19 on children and vulnerable individuals. Throughout all these accomplishments, we managed to organize our thoughts and maintain our energy. We did this individually and as a team. And all this while we attending to our homes, the people under our care, and ourselves.

Everything is changing, and it is the most vulnerable who are suffering the dire consequences.

The pandemic must not define our entire year, but it certainly feels like it has, and it looks like the pandemic will persist into the near future. What will happen afterward remains uncertain. However, what we do know for certain is that this pandemic has exposed the neglected problems of inequality and injustice. We know that upheavals, such as this one, will continue to have a disproportionate impact on the most vulnerable. The pandemic has frustrated us but also reassured us of our mission. Everything we have learned this year and the one before will continue to motivate our thoughts and actions. We will continue to address the challenges faced by the children and vulnerable individuals who are affected by inequality and injustice, and we will continue to assist in alleviating the suffering caused by poverty, violence, discrimination, and natural disasters.


I have been thinking about what I would wish for 2021. In doing so, I could not help but recall what I wished for 2020. At the end of 2019, I wrote:

"Approaching 2020, I'd like to reiterate the wish that I made on PUSKAPA's anniversary last August. I wish us the ability to move at a speed that allows us to think, to understand the problem, and to catch those who are too small, they fall through the cracks. I wish us the capacity to extend our physical, emotional, and intellectual presence in creating and maintaining safe spaces for difficult issues to be resolved: issues of exclusion, harm, invisibility, and injustice."

I'd say that we, despite the tremendous challenges of 2020, managed to succeed in this endeavor.

We strive to protect our staff and partners with a number of initiatives and policies.

Our first priority is to ensure that all Employees retain their jobs, and we are committed to carrying the PUSKAPA team through these difficult times as best as possible in a spirit of solidarity and kindness. We implemented remote working from March 2020 to June 2021 (or until the situation is more under control) through a Coordinated Remote Working mechanism. This was made possible through adjustments in operational office guidelines, the provision of internet data packages, the provision and maintenance of computer devices and a virtual work platform, assistance in the form of work-from-home facilities, and adjustments to working hours.

We documented and prepared a quick referral list for COVID-19 and other illnesses or emergency situations.

We issued updates on the latest developments regarding COVID-19 to all employees on a regular basis. We provided subsidized psychological counseling for employees in need.

All of our employees have agreed to a policy of limited information disclosure in the case of exposure to COVID-19 for the purpose of tracing and moral support.

We provided information on COVID-19 to educators and FISIP UI teaching staff through a series of knowledge sharing sessions on PUSKAPA policies related to the pandemic that involved research institutions and civil society organizations (TURC, ICJR, IJRS, LEiP, LP2SP FISIP UI), which included We ensured that the activities we carry out with partners guarantee their safety and mitigate the risks they may face. In addition, we adapted our office infrastructure to ensure adherence to health protocols once it is safe to resume operations.

OUR IMPACT IN 2020



We encouraged improvements in the CRVS system.

We provided technical assistance to the central government in establishing the National Secretariat for Civil Registration and Vital Statistics (AKPSH), and contributed to policy strengthening and capacity development of CRVS facilitators in the regions, and to the development of a Village Authority-Based CRVS Services system (LABKD).

We strenghtened the concept of child development and social welfare.

In collaboration with UNICEF, we facilitated a series of thematic discussions with the Directorate of Poverty Reduction and Community Empowerment (PKPM—formerly Poverty Reduction and Social Welfare/PKKS) and the Directorate of Family, Women, Children, Youth and Sports (KPAPO) at Bappenas, as well as Ministry of Social Affairs (Kemensos), Ministry of Women's Empowerment and Child Protection (KPPPA), which involved experts who discussed future strategies and efforts to strengthen systems and services for the protection and social welfare of children in Indonesia.

We were actively involved in advocacy to push for policy changes.

- Throughout 2020, we carried out various advocacy activities related to institutionalization, supported collaboration among service providers, shared experiences and good practices, and engaged in various consultations with the primary objective of improving public service, especially services related to the CRVS system.
- We reviewed and provided input on several Bills (RUU) currently being discussed by the government. These bills have the potential to exacerbate existing problems or otherwise create new problems for children and vulnerable groups, and do not resolve existing root causes. These Bills included the Bill on Family Resilience, Bill on the Elimination of Sexual Violence (RUU PKS), and Bill on Personal Data Protection (RUU PDP).

We built collaborative work in research and advocacy.

- Together with SurveyMETER, we collaborated in testing the entire instrument and survey for the Longitudinal Study of Indonesian Children and Family (SLAK).
- Together with the Alliance for the Elimination of Violence against Children (PKTA), we advocated for further use of the 2018 National Survey of Children and Adolescents' Life Experience (SNPHAR) data. PUSKAPA urged for the publication of a complete analysis of the 2018 SNPHAR so that the prevention of violence against children can be carried out more precisely and in an evidence-based manner.
- Together with the Legal Identity Working Group, we oversaw the revision of the Population Administration Law to ensure that it was more inclusive.
- Together with CISDI, we provided technical training assistance to Pencerah Nusantara volunteers in their efforts to deal with COVID-19 at the primary level through the strengthening of Puskesmas programs and the involvement of civil society at the grassroots level.
- **Together with CISDI**, we provided technical training assistance

- Together with Sahabat Kapas, we provided capacity building to strengthen youth advocacy, argued for an increase of capacity in Juvenile Detention Facilities (Bapas), and shared the findings from our study of the implementation of the Juvenile Criminal Justice System (SPPA).
- Together with ELSAM & the CSOs' Alliance, we supported advocacy efforts to improve personal data protection, especially in regard to children's data privacy in the use of digital technology.
- Together with Columbia University, we supported research and advocacy efforts to improve evidence-based child protection in Indonesia.
- Together with the London School of Tropical Medicine and Hygiene, we completed a mentoring training module that applied a social norms approach to civil society programs.
- Together with the National Alliance for Penal Code Reform, we continued to advocate for postponing and improving the Draft Criminal Code (RKUHP) as well as for legal reform to ensure protection for all vulnerable groups.

• **Together with Latih Logika**, we supported young people who wish to engage in critical thinking by providing free online critical thinking courses, which we advertised on social media, and we conducted FGDs with high school students.



We created space for healthy public discussion.

Through PUSKAPA's Learning Series and our social media accounts, we provided opportunities to discuss the importance of critical thinking for young people, to think about how adults respond to children involved in protests, and to determine what we can do to support children who are bullied as well as how to prevent this.

Our discussions were aimed at getting participants to be more thoughtful before they react to an issue.

In addition to the main report, PUSKAPA also published seven policy papers that offer a number of recommendations that are based on the study of the various sectors involved in implementing the SPPA Law.

PROGRAM MANAGEMENT

Program Management Highlights

PUSKAPA manages its programs throughout the conceptualization, design, and activity implementation stages. The program management process can take place over several years, and program outputs contribute directly to solving the problems experienced by children and vulnerable groups. 11

Program Management by PUSKAPA includes:

- Formulation of strategies and the allocation of available resources from within PUSKAPA as well as from outside the organization in order to achieve Program objectives
- Risk identification and management to address uncertainties and complexities inherent in the Program implementation, which include social, political, economic changes, or geographic events that may affect Program results
- Coordination with partners and relevant stakeholders to find ways to increase Program impact
- Planning and implementation of monitoring and evaluation to track changes, inform the direction of changes, and to improve future program planning

Inclusive and Accountable CRVS

Since 2015, PUSKAPA has been working with the Australian-Indonesian Government Partnership through the KOMPAK program to assist the Government of Indonesia in strengthening its Civil Registration and Vital Statistics (CRVS) System. This program is organized to strengthen CRVS services from the village level to the national level, to increase the ownership ratio of legal identity documents, and to produce accurate and up-to-date population data. We believe that a CRVS system that operates in an inclusive, effective, and accountable manner will improve basic services (health, education, social protection, and economic development) and ensure that resource are allocated on the basis of an accurate database and thus improve welfare.

This program will conclude in 2022. Over the course of this program, we have seen various positive outcomes, both direct and indirect, as a result of our chosen approach. By the end of the program, we A Partnership with KOMPAK, 2015 - 2021

will have produced a complete picture that documents the success of the KOMPAK program in strengthening an inclusive and accountable CRVS system, and we will have identified the work that remains to be done as well as the lessons learned from less successful approaches. These documentation results are expected to inform upcoming programs and to ensure the success of future efforts to strengthen the CRVS system.

Strengthening Evidence for Child Protection and Wellbeing

PUSKAPA and UNICEF have been in a partnership since 2017, which aims to strengthen and expand data-based, interdisciplinary, and effective policy advocacy in order to solve complex problems that affect the wellbeing of children in Indonesia.

The 2017-2020 PUSKAPA and UNICEF partnership aims to:

- Produce and disseminate evidence, encourage rigorous research, and develop new 1 methodologies to obtain meaningful data about the hardship of children.
- Turn this evidence into policy proposals and improve the quality of policy debates 2 and public dialogues on children's difficulties within the broader development agenda.
- Provide a political approach to support PUSKAPA's focus areas and to frame them as 3 priority issues, including issues such as social inclusion and protection; legal identity, civil registration and vital statistics; and access to justice for children and vulnerable individuals.

PUSKAPA was established through collaboration between Bappenas, the University of Indonesia, and Columbia University. This year, PUSKAPA has strengthened its partnership with Columbia University through the CPC Learning Network in order to ensure that the children's rights approach becomes a priority in development policy, and to ensure that the rights of all children, but especially those most affected by adversity, are upheld, and that they receive the support they need.

We contributed to the handling of the COVID-19 pandemic at both the national and local level.

Since the first case of COVID-19 was confirmed by the Government on March 2, 2020, Indonesia has officially been in a state of emergency. Working with our partners in Government and civil society, we provided technical assistance in the form of:

- Together with the National Task Force on COVID-19, we formulated:
 - 1. A Cross-Sector Protocol for the Prevention and Handling of Violence, Mistreatment, and Neglect against Children and the Provision of Supplementary Care during the COVID-19 Pandemic.
 - 2. A Cross-Sector Protocol for the Release and Detention Suspension of Children through Assimilation, Rehabilitation, and Unconditional Release Programs.
 - **3.** A Protocol for Children in Detention Facilities (LAPAS/LPKA) who are Granted Assimilation and Integration in the Context of Preventing and Controlling the Spread of COVID-19.
 - 4. AProtocol for Child Data Security and Use in the Context of COVID-19 Prevention and Control.
- We assisted 12 districts in data collection and the organization of BLT-DD and Cash Social Assistance (BST) and Social Safety Net (JPS) programs that were set up in response to COVID-19.

- Together with the Ministry of Villages, Development of Disadvantaged Regions, and Transmigration (Kemendes PDTT), we formulated governance guidelines and mechanisms for data collection and for setting up the Village Fund Direct Cash Assistance (BLT-DD) scheme.
- Together with Bappenas, we provided analysis and formulated policy recommendations for the protection of children and vulnerable groups during the COVID-19 recovery process.
- Together with the Office of Population Administration and Civil Registration (Disdukcapil) in 12 districts across 4 provinces, we trained village-level officers to identify vulnerable groups during the COVID-19 pandemic.
- We supported CISDI in providing assistance to social and health volunteers via debriefing programs and monthly case discussions.



We contributed our expertise to the handling of the COVID-19 pandemic at the international level.



- In collaboration under the Lancet
 Institutional Care Reform Commission
 Group, we issued policy
 recommendations for the health and
 safety of children in institutions around
 the world during the COVID-19
 pandemic.
- In collaboration under The Alliance for Child Protection in Humanitarian Action UNICEF Task Force, we produced a Technical Note titled "COVID-19 and Children Deprived of their Liberty".
- We joined Columbia University's
 Program for Forced Migration and Health as well as the COVID-19 Knowledge Hub.
- In collaboration under the Advisory Board of Columbia University's CPC Learning Network, and together with AfriChildCenter Makarere University Uganda, and GRAPE Burkina Faso, we published an action plan against racism and identity-based injustice in humanitarian and development work in the context of the COVID-19 pandemic.
- We participated in a limited internal discussion panel with the Australian Government Department of Foreign Affairs (DFAT), The Asia Foundation, which is based in San Francisco, and the Government of Indonesia to discuss data for an inclusive COVID-19 pandemic response.


We secured the Implementation of Presidential Regulation No. 62 of 2019 with the establishment of the National Secretariat for Accelerating Population Administration for the Development of Vital Statistics (Seknas AKPSH).



The government has shown its commitment to improving the population administration system by issuing Presidential Regulation (Perpres) No. 62 of 2019 on the National Strategy for the Acceleration of Population Administration for the Development of Living Statistics (Stranas AKPSH).

To ensure that implementation proceeds effectively, we provided technical assistance to the government in establishing the National Secretariat for Population Administration for the Development of Vital Statistics (Seknas AKPSH). PUSKAPA's contribution included developing an outline for the Seknas AKPSH Work Plan, providing technical notes regarding the role of Stranas AKPSH and its benefits for relevant sectors, and assisting with the primary tasks and functions (Tupoksi) across line ministries.

We institutionalized a Village Authority-Based CRVS Service System (LABKD).



We assisted local governments in developing a village-based CRVS system and service in 219 villages across 16 districts. The development of this system was carried out by encouraging innovation, reviewing regulations, developing standard operating procedures (SOPs), and evaluating the implementation of CRVS services from village to district levels.

We served as both a resource and facilitator in various activities to encourage a better CRVS system in KOMPAK-assisted areas, including Aceh, Central Java, West Nusa Tenggara, South Sulawesi, East Java, and Papua, as well as for national-level activities. Some of these activities discussed the institutionalization (planning and budgeting) of the LABKD mechanism, drafting of supporting regulations for the acceleration of CRVS service programs, mechanisms for appointing and increasing the capacity of village CRVS officers, and formulating the monitoring and evaluation guidelines for the proposed mechanism.

We criticized the Proposed Family Resilience Bill.



We criticized the Draft Law on Family Resilience (RUU KK) that is currently being discussed by the government, and established a joint support together with the Alliance for the Elimination of Violence Against Children (PKTA) by developing an advocacy sheet to harmonize perceptions about the bill. We argue that the legislation outlined in RUU KK could potentially give rise to new problems as the draft was not based on evidence. Furthermore, it contradicts the principles of the Convention on the Rights of the Child (CRC), which state that the government is responsible for providing an ecosystem for children to thrive and to be protected against violence. RUU KK places an excessive burden on families. However, it is families who should receive adequate support from their surrounding ecosystem.

We encouraged the Revision of RUU PKS to strengthen protection for victims of sexual violence.




We provided input on the Draft Law on the Elimination of Sexual Violence (RUU PKS) currently being discussed by the government. We argue that while the bill can offer a solution to the problem of sexual violence, it also needs to re-reformulate its approach to criminal punishment and social services in order to ensure their effective implementation. Throughout 2020, we participated in multiple discussions with line ministries and agencies, civil society organizations, and various experts to discuss the Draft Law. Our recommendation was that RUU PKS be written in a manner that is clear and easy to understand for all members of the public – from law enforcement officials to victims of sexual violence – in order to achieve the expected benefits.

We advocated for the Personal Data Protection Bill.

Together with the Coalition for Personal Data Protection (PDP), PUSKAPA provided input on strategic advocacy plans as well as capacity building related to the issue, and supported the preparation of a collective position paper. We were also involved in various public discussions surrounding the PDP Bill, especially about the protection of child data privacy in using digital technology.

We conducted capacity building for CRVS Facilitators at the village level.



During the pandemic, we organized capacity building activities on COVID-19 and trained CRVS service facilitators at the village level in KOMPAK Program areas. These activities ensure that village facilitators are able to help villagers safely record vital events and obtain relevant population documents. Owning legal identity documents helps community members to access basic services, obtain protection, and find opportunities to improve their welfare. In addition, population data and information recorded at the village level can serve as a basis for further developing programs, policies, and services in villages.

We conducted capacity building for child facilitators with Sahabat Kapas.



We facilitated and presented in a series of activities to increase the capacity of Sahabat Kapas facilitators. Sahabat Kapas is an institution that provides psychological counseling, personal development activities, skills training, and reintegration support for children in conflict with the law. We supported Sahabat Kapas in improving the advocacy skills of facilitators from various regions. In addition, we also contributed to capacity building activities for social workers (Peksos) and Community Advisors at Correctional Facilities (PK BAPAS) with the goal of acquiring theoretical knowledge, technical and regulatory information, and other relevant facts relevant to the Juvenile Criminal Justice System (SPPA).

LEARNING TO WORK PROGRAM AT PUSKAPA BATCH 2







This program was designed at PUSKAPA because we refuse to complain about a lack of competence among fresh graduates. Instead, we support them so they are better prepared for their work. Unlike traditional "internship programs," we believe that familiarity with professional settings, especially in the child protection sector, is just as important to fresh graduates as having technical skills and knowledge.

The Learning to Work Program at PUSKAPA was held for the second time, but due to the pandemic it had to be conducted virtually. Four undergraduate students were selected from various bachelor's degree programs (law, communications, criminology, and public health). During four months (March 2-June 30, 2020), students explored the three main focal points of PUSKAPA (Inclusion and Social Protection, CRVS, and Access to Justice), and worked with the Trifecta team (Monitoring and Evaluation, Knowledge Management, and Communications). Only two of these four students completed the program in its entirety.

Our interaction and collaboration with youths not only helps increase their interest in working in the child protection sector, it also expands and enriches our own perspective on young people. Equally important is the chance for PUSKAPA to introduce the values of tolerance and diversity to the young people participating in this program.

KNOWLEDGE SHARING & LEARNING

Learning Series

PUSKAPA Learning Series is a series of public dialogues on current issues surrounding child protection and wellbeing in Indonesia. In the PUSKAPA Learning Series, participants can interact with experts from Indonesia and other countries - from academics to policymakers, practitioners to civil society 18

leaders - who share their latest scientific findings, policy recommendations, and the lessons they have learned from the real world.

In 2020, we organized three Learning Series events, all of which were conducted virtually.



Children involved in public protests have recently received a lot of public attention, from a wide range of perspectives. This has particularly been the case for high school students participating in recent protests. Some argue that high school students should not have joined these protests, as it suggests that they have abandoned their obligation to study from home. Some also argue that involving children in protests is tantamount to exploitation. In this series, we explored various perspectives on how to respond to and support children involved in protests, and we presented a wide range of views: from parents to the students themselves, as well as expert opinions of program managers working in child support and protection.



Brown Bag Discussions



At PUSKAPA, we never stop learning. For our brown bag discussions, we invited speakers - PUSKAPA staff members as well as outside experts to teach us new things. Through this discussion, participants gained a deeper understanding of the results of the 2020 DKI Jakarta PPDB impact simulation study, explored arguments for amending the policy, and compared the PPDB results of 2019 and 2020.


