A 2021 YEAR END NOTE

FROM THE
DIRECTOR



On the last day of 2021, I read a short article on the evolution of bathroom design in American houses. The layout, the materials used, the plumbing, and the bathroom placement in a house evolve as public health issues arise. Most of us are already aware of this. Modern sanitation results from the experience of people suffering from various disease outbreaks and aspiring to prevent them.

I am constantly inspired by how humans are provided with the will to “learn and unlearn” to survive and improve their lives. Once people realized that basic hygiene could prevent disease and death, they invented toilets, built bathrooms inside their houses, installed pipes to allow water to flow easily and facilitate their daily routine, and so forth. Looking back to 2021, I am highly appreciative of how PUSKAPA remains eager in learning and re-learning.

PUSKAPA conducted six studies, each of which helps us to further comprehend the governance of social care services, the situation of children and youth in Indonesian cities, the ownership and use of legal identities in our workplace, the landscape of legal identity service innovation, and Indonesia’s developments regarding the 16th goal of the SDGs. Furthermore, a number of ongoing studies investigated the challenges and opportunities for youth civic engagement and girls’ citizenship.

PUSKAPA continued its advocacy works despite the pandemic era. We partnered with governmental and non-governmental organizations in transforming evidence into policies to reinforce the protection, justice, and welfare of all children and vulnerable people. PUSKAPA also took part in collaborations and coalitions, supporting the campaigns and work of the existing and new partners. New alliances grow stronger while the existing ones endure.

PUSKAPA also continued to build institutionally through strengthening organizational strategies and governance. We made progress with, among others, the mechanisms to prevent and address harassment as well as violence based on gender and other social identities. PUSKAPA has endeavored to maintain the organization while coping with the ongoing pandemic and its implications: on funding, working methods, and the capacity of PUSKAPA itself.

These are made possible by PUSKAPA’s enthusiasm and capability to learn, determination to act on a knowledge basis, and willingness to re-learn and relinquish outdated ways that, albeit the comfort and familiarity, may be ineffective and even dangerous.

Apart from learning and re-learning, how bathrooms were invented also reminds us of inequality. To this date, some individuals are not privileged enough to enjoy the advancement of science and technology as well as its good impact, including on health. Individuals who can afford such privilege seize more opportunities to protect themselves from outbreaks. For instance, they are likely to avoid the COVID-19 transmission and are less affected socially and economically by various restrictions as a consequence of the pandemic. Reminiscing 2021 also inspires me to be more grateful as PUSKAPA sustainably pays attention to those bearing negative impacts in any situation and what can be done to mitigate those impacts.

Collectively, everyone involved in PUSKAPA agrees that, to survive the inequality before and after the pandemic, research, advocacy, and service should highlight those suffering the most.

I read somewhere that one must possess and practice three things to build a habit: intention, attention, and repetition. The year 2021 has convinced me that PUSKAPA holds strong potential to put “thinking and acting wisely” into the institution’s habit.

I sincerely hope that, in 2022 and at all times, we retain enough energy and power to show kindness and compassion in everyday life.

Initiating Changes



Through partnerships with the Government of Indonesia (through the Ministry of National Development Planning/National Development Planning Agency or Bappenas) and KOMPAK, PUSKAPA proceeded with advocacy, technical assistance, and capacity sharing to help vulnerable groups reserve legal identity rights, benefit them to obtain basic services, and strengthen the use of citizen data for the design and improvement of programs and policies in **219 villages spread over 22 assisted districts in Aceh, Central Java, East Java, West Nusa Tenggara, South Sulawesi, Papua, and West Papua.**



PUSKAPA supported KOMPAK to replicate the mentioned program in approximately **27 other districts.**



Together with Columbia University's CPC Learning Network, PUSKAPA strengthened the dialogue and the mainstreaming of diversity, equality, and inclusion in fulfilling children's rights at the global level.



Together with UNICEF, PUSKAPA continued evidence-based advocacy to strengthen the child protection system in Indonesia.



Together with the Centre for Indonesia's Strategic Development Initiatives (CISDI), PUSKAPA encouraged primary health services and the handling of the COVID-19 pandemic for vulnerable groups.



PUSKAPA fostered the implementation of the National Strategy for the Acceleration of Strengthening Civil Registration and Vital Statistics (CRVS) through the CRVS National Secretariat with KOMPAK and Vital Strategies.



Together with The London School of Hygiene & Tropical Medicine, PUSKAPA reinforced the mentoring program on the implementation of a research-based approach to social norms and advocacy in strengthening child protection.



Together with the Institute for Criminal Justice Reform (ICJR) and Indonesia Judicial Research Society (IJRS), PUSKAPA was involved in a series of public dialogues and provided input on the Bill on the Crime of Sexual Violence.

Ongoing Research Conducted in 2021



1 Study on the Understanding of Youth Involvement in Climate and Environmental Issues in Indonesia

This report would be completed by mid-July 2022

In general, this study was conducted to grasp the actions of youth related to climate and environmental issues, to identify the driving factors for youth involvement, and to explore successful models of youth involvement with an impact on changing social norms and policies.

2 Study on the Strengthening of Civil Registration and Vital Statistics/PASH

(PUSKAPA - KOMPAK)

This report completed by June 2022

In general, this study was conducted to demonstrate a coherent analysis and summary of what has happened during the last seven years of the PASH Program and to assess the progress of the theory of change to be achieved in the long term.

3 Policy Review on Child Protection in the Child Criminal Justice System in Indonesia

(PUSKAPA, Bappenas, Ministry of Law and Human Rights, and UNICEF)

This report would be completed by mid-2022

In general, this study was conducted to answer the question of how the protection of children in conflict with the law through assistance and rehabilitation is regulated in the laws and regulations.

4 Consultation with Youth and Preparation of Position Papers for the G20 Forum

(PUSKAPA, Bappenas, Ministry of Home Affairs, and UNICEF)

This position paper was completed in March 2022

In general, consultations with youth and the preparation of position papers were carried out to provide input for the Indonesian delegation in the G20 meetings/forums.

5 Technical Studies to Strengthen the ATENSI Program

(PUSKAPA, Bappenas, Ministry of Social Affairs, and MAHKOTA)

This study report was completed in February 2022 and was not released to the public

In general, this study was conducted to prepare appropriate support for the Social Rehabilitation Assistance Service (ATENSI) of the Ministry of Social Affairs by perceiving the readiness for the ATENSI Program implementation, identifying risks that may arise, and preparing a mitigation plan. In addition, the study also aims to provide an objective picture of the ATENSI program and its implementation arrangements, generally observe the existence of the ATENSI Program in the overall social welfare system in Indonesia, and recommend improvements in service provision and its governance.

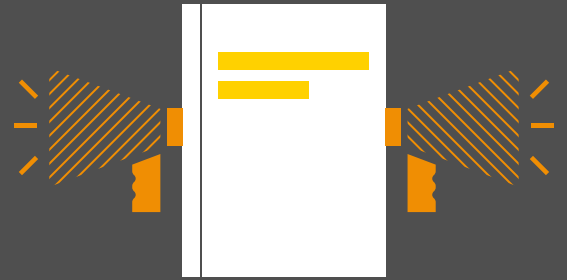
6 Documenting the CRVS Innovation Learning in Indonesia: Demonstrating the Feasibility of an Inclusive and Accountable CRVS System

(PUSKAPA - World Bank)

This report was completed in 2021 and was not released to the public

This study aims to inform the Indonesian Government regarding the innovation of the Civil Registration and Vital Statistics (CRVS) system to strengthen the delivery of health and social services. This study synthesised comprehensive learning concerning the national and sub-national CRVS strengthening initiatives in Indonesia.

This study report aims to identify the governance situation and CRVS provision as well as its relation to health and education services. This study was also conducted as a basis for future adjustments and improvements to the program as it was designed to obtain more information about the changes occurred between 2015 and 2019.

2 Bridging Inclusion: Understanding Vulnerability in Indonesia's CRVS System



(Bappenas-PUSKAPA-KOMPAK)

The report was launched on a limited basis in March 2021.

This study identified vulnerable groups for CRVS, the characteristics of their vulnerability, and the barriers they have experienced through a review of various documents and literature. This study also examined good practices and analysed them as a basis for recommendations for a more inclusive civil registration system that records every individual without exception.

3 Civil Registration Services in Disaster Situations



(Bappenas-PUSKAPA-KOMPAK)

The report was launched on a limited basis in March 2021.

This report aims to provide the information required to strengthen the governance of disaster preparedness and management in Indonesia based on case studies of earthquake disasters in Lombok and Sigi districts in 2018.

4 Handbook for Children's Participation in Research in Indonesia

(PUSKAPA)

5 The Situation of Children and Young People in Indonesian Cities

(Bappenas-PUSKAPA-UNICEF)

This study report aims to explore the characteristics, well-being, and lived experiences of children and young people, providing a critical foundation for policy and programming to turn the myth of urban opportunity into a reality for all children and young people, particularly those who are marginalised.

The report of Indonesia VNR in 2021 was launched by the SDG's secretariat in June 2021.

In assisting the preparation of the Voluntary National Review (VNR) or reports on the government's achievements and progress in achieving the Sustainable Development Goals, in particular Goal 16 on Peace, Justice, and Strong Institutions, PUSKAPA is involved as a contributor, providing technical and strategic advice, drafting, consulting meetings, collecting data, and compiling key messages. In the previous VNR report in 2019, PUSKAPA has also assisted the SDGs Secretariat in its preparation.

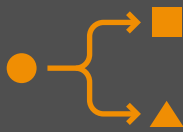

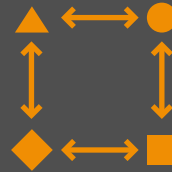
Program Management Highlights

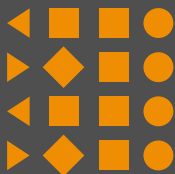
Program Management by PUSKAPA includes:



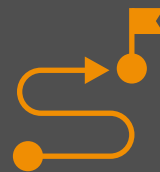
Formulation of strategies and the allocation of available resources both inside and outside PUSKAPA to work together to achieve program goals.

Inclusive and Accountable CRVS

A Partnership with KOMPAK, 2015–2022

Since 2015, PUSKAPA has collaborated with the Australia-Indonesian Government Partnership through the Kolaborasi Masyarakat dan Pelayanan untuk Kesejahteraan (KOMPAK) program. This program has consistently carried a message to assist the Government of Indonesia in strengthening its Civil Registration and Vital Statistics (CRVS) services and system. We believe that an inclusive, effective, and accountable CRVS system will improve basic (health, education, social protection, and economic development) services and ensure that the resource is allocated based on an accurate database so that people's welfare increases.

In 2021, our priority is to ensure the availability of resources and policies supporting CRVS services at the village to district levels, as well as to build a mechanism for utilizing CRVS data for development planning. Inclusive services can also be achieved if service providers are provided with adequate guidance and the capacity to identify vulnerable groups who face more difficulties in accessing services. In collaboration with KOMPAK, we also intend to ensure that adequate institutionalization and replication tools are available in our assisted areas towards the end of the program in 2022.

Technical Assistance to Support the Implementation of the National Strategy for the Acceleration of Strengthening Civil Registration and Vital Statistics (Stranas AKPSH)

Partnership with Vital Strategies 2021-2023

The year 2021 was the initial momentum for strengthening the collaboration between PUSKAPA, Vital Strategies, and Bappenas to support the implementation of the Stranas AKPSH, especially in aspects of birth registration, recording of deaths and their causes, as well as processing vital statistics data. Various series of capacity-building meetings and work plans have been held to ensure smooth implementation of the program in 2022–2023.

This collaboration agreed on three main approaches, namely 1) mapping of policies and business processes for recording births, deaths, and causes of death; 2) technical support for improving business processes for recording births, deaths, and causes of death; and 3) technical support in formulating strategies for collecting, processing, and disseminating vital statistics data.

3

Strengthening of Institutional Development through Inter-University Partnerships for the Protection and Quality of Life of Children

A Partnership with CPC Learning Network-Columbia University, 2009–2023

Since its establishment, PUSKAPA has continued to strengthen its collaboration with Columbia University. Together with CPC Learning Network, PUSKAPA continues various programs to ensure that the Government of Indonesia puts children's rights and quality of life as a development priority,

and that all children, particularly those who are most in need, receive the rights and support they require. Through this collaboration, PUSKAPA published a Handbook for Children's Participation in Research in Indonesia.

4

Strategic Partnership for Child Protection and Social Policy

A Partnership with UNICEF Child Protection, 2021–2023

PUSKAPA continues its partnership with UNICEF, which began in 2014. During this period, the program management is focused on efforts to strengthen evidence-based policies in response to children's risk of inequality, poor care, and violence. We recognised the need of processing evidence in order to use it as policy recommendations and material for public dialogue. We also realised the importance of ensuring an adequate framework in the civil registration, social welfare, and justice systems sector, as well as the importance of various capacity-building efforts to strengthen child protection services at the central and regional levels.

During 2021, PUSKAPA supported the Government of Indonesia in compiling a roadmap for the implementation of the Juvenile Criminal Justice System Law. PUSKAPA also supported various civil society organizations, such as Sahabat Kapas, in youth capacity-building programs on issues of social protection and inclusion, civil registration and vital statistics, and access to justice. PUSKAPA also developed various skill-based capacity-building instruments such as advocacy techniques, critical thinking, and guidelines for drafting policy papers.

As a follow-up to the launch of *Racing Against Time: A Policy Paper on the Prevention and Handling of COVID-19 Impacts on Children and Vulnerable Individuals in 2020*, PUSKAPA, with the support of KOMPAK and UNICEF, organised the first and second series of this COVID-19 Vulnerability online discussion in January and February 2021. The discussion aims to disseminate main ideas, increase media awareness, and sharpen the six policy review recommendations by integrating the perspectives from ministries/agencies with CSOs. This agenda was held by PUSKAPA and supported by KOMPAK and UNICEF. In the second series, The Conversation Indonesia was chosen to be the media partner for the activity.

On June 23, 2021, Bappenas, together with PUSKAPA and KOMPAK, launched a study report on civil registration and basic services (Dukyandas) entitled "Strong Institutions, Resilient Communities" in conjunction with the launch of the Stranas AKPSH Working Group. The speakers at the event included Pungky Sumadi (Deputy for Demography and Manpower, Bappenas), Zudan Arif Fakrulloh (Director General of Population and Civil Registration, Ministry of Home Affairs), Dan Woods (Counsellor of Human Development Section, DFAT), Muhammad Cholifihani (Director of Population Planning and Social Protection, Bappenas), Akhmad Sudirman Tavipiyono (Acting Secretary of the Directorate General of Population and Civil Registration, Ministry of Home Affairs), Sri Wahyuni (Coordinator of Education Service Facilitation and Development of Community Socio-Cultural Capital, Directorate of Socio-Cultural Development, Village and Rural Environment, Ministry of Village, Development of Disadvantaged Regions, and Transmigration), and Evi Rahmi Kasim (Director of Social Rehabilitation for Persons with Disabilities, Ministry of Social Affairs).

The Dukyandas study demonstrated that, despite the many achievements achieved, some challenges to the CRVS system remained to be found. The study also revealed that some respondents did not have legal identity documents, mostly due to cost and time constraints.

The launch of the study and the Stranas AKPSH Working Group were attended by 489 participants from various ministries and agencies, media, research institutions, civil society organizations, and development partners. Three national online media reported the event.

This alliance works to ensure that the Draft Bill on Criminal Code (RKUHP) protects and does not criminalize certain groups. Over the past 3 years, PUSKAPA and the Alliance have produced several policy papers, campaign products, discussions, and public seminars.

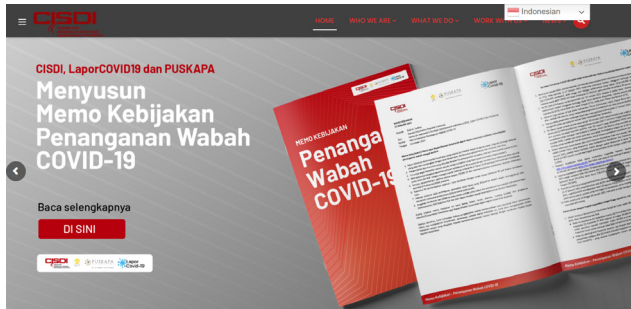
The last activity performed by PUSKAPA and the Alliance included a public dialogue, in which Feri Sahputra, PUSKAPA's Lead for Access to Justice, became one of the speakers. In the event, Feri shed light on the development targets that might be hampered if the RKUHP was passed while still containing articles that criminalize certain groups.

Policy Memo of the Ministry of Health

To accelerate the achievement of successful handling of the COVID-19 pandemic, PUSKAPA, together with the Centre for Indonesia's Strategic Development Initiatives (CISDI) and LaporCOVID19, issued a policy memo addressed to relevant policymakers, one of which is the Ministry of Health. In the policy memo, joint work across technical and coordinating ministries appears to be one of the keys to successfully handling the COVID-19 pandemic in Indonesia.

6

Technical Support for Strengthening Civil Registration and Vital Statistics (PASH) System

At the national level, PUSKAPA and KOMPAK provided technical support to Bappenas in implementing the Stranas AKPSH through the national secretariat established. Two AKPSH National Secretariat experts have been recruited and various inter-agency coordination meetings have been held. Through the Legal Identity Working Group, PUSKAPA also supported discussions and advocacy for the amendment to the Civil Registration Law.

In collaboration with KOMPAK, PUSKAPA also provided technical support to the Ministry of Villages, Development of Disadvantaged Regions, and Transmigration (Kemendes PDTT) by compiling the Guideline for Facilitating Social Protection in Villages (Panduan Perlinsos). This guideline serves as one of eleven guidelines currently being developed by the Ministry of Villages, Development of Disadvantaged Regions, and Transmigration to promote the implementation of the Village SDGs. The Guideline for Facilitating Social Protection in Villages was prepared to respond to villages' need to recognize their authority and role in serving social protection in

villages extensively. The guideline was prepared to assist villages in implementing social protection through the Social Welfare Centre (Puskesmas) and Posyandu in villages. It shares practical knowledge for villages to facilitate and implement social protection, especially for people in need or the most vulnerable.

PUSKAPA has also compiled the Technical Guidelines for Data Collection on Vulnerable Groups for CRVS. The guideline serves as a guideline for data collection of individuals or groups with difficulty in obtaining civil documents due to obstruction by access, unresponsive systems and services, and even discriminatory treatment. The Technical Guideline for Data Collection on Vulnerable Groups is a continuation of the Vulnerability Study which classified 12 vulnerable groups for CRVS based on 3 layers of vulnerabilities, i.e. vulnerabilities due to access obstruction, vulnerabilities due to unresponsive services, and vulnerabilities due to social identity.

At the subnational level, PUSKAPA also supported local governments to develop technical plans and conduct capacity-building activities for officers assisting with the civil registration process in KOMPAK areas. From April to June 2021, PUSKAPA held various trainings for trainers (TOT) of PASH facilitators, including in Pemalang (Central Java), Trenggalek and Lumajang (East Java), Jayapura (Papua), and South Manokwari (West Papua). Training at the provincial level was also conducted in West Nusa Tenggara and South Sulawesi.

Assistance to local governments was also provided in developing monitoring and evaluation instruments for the Village Authority-Based Administrative Service (LABKD). A series of workshops was held to develop and test the monitoring instruments, including in Brebes (Central Java), Bondowoso (East Java), and Bantaeng and Pangkep (South Sulawesi). In West Nusa Tenggara, the development and testing of monitoring and evaluation instruments was also carried out for the implementation of the acceleration of legal identity ownership through cross-sectoral collaboration.

PUSKAPA was involved in drafting regulations for the application of Integrated Poverty Information System (SIKAT) in Lumajang (East Java) and District Information System (SIKAB) in Pacitan (East Java) as an endeavour to support the development of information systems that link civil registration data and other sectors. In addition, PUSKAPA also supported the preparation of regulations regarding the implementation of regional regulations concerning the civil registration in Lumajang (East Java). Support for the preparation of regulations was also provided in West Lombok and Central Lombok (West Nusa Tenggara).

Besides, PUSKAPA provided technical support for the development of standard operating procedures (SOP) for civil registration services in Trenggalek and Lumajang (East Java). Regarding budgeting for civil registration services, PUSKAPA also promoted discussions on budgeting plans for the Village Authority-Based Administrative Service (LABKD) in Brebes, Pemalang, and Pekalongan (Central Java),;and North Lombok and East Lombok (West Nusa Tenggara).

Advocacy for the Bill on the Sexual Violence Crime

A collaboration with ICJR and IJRS

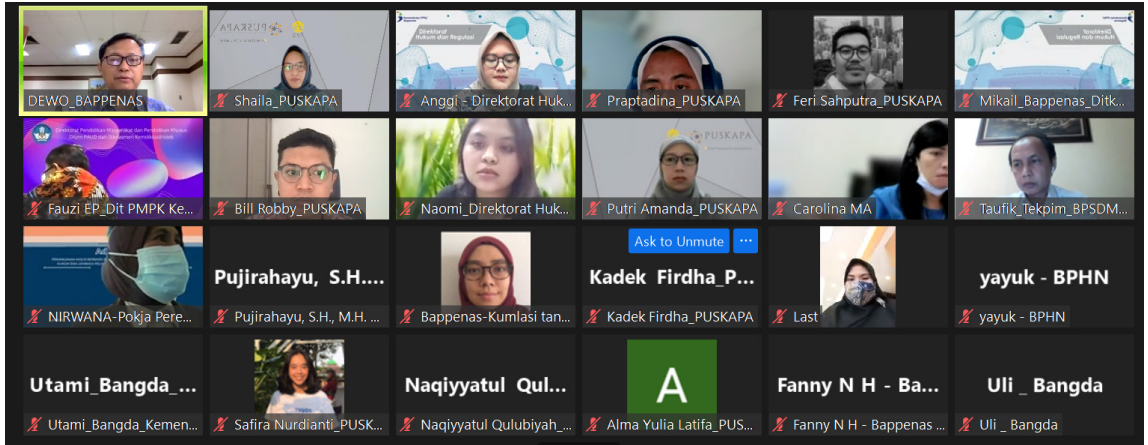
The civil society coalition has been advocating a bill to prevent, respond to, and reinforce law enforcement for sexual violence cases since 2016. The House of Representatives (DPR) had set the Bill on the Sexual Violence Crime as one of their priorities in 2021.

PUSKAPA has collaborated with the Indonesia Judicial Research Society (IJRS) and the Institute of Criminal Justice Reform (ICJR) to advance a policy brief as input for the bill. As highlighted in the brief, our primary focus is on how the law should accommodate more explicit regulations concerning criminal acts, law enforcement procedures, and protection and assistance guarantees for sexual violence victims.

Apart from that, we also pointed out the need to accommodate regulations on the roles of local governments in responding to and preventing sexual violence cases. We collaborated with ICJR and IJRS to monitor the bill's progress in the DPR as the legislative institution. We have organized several meetings to update the advocacy and develop its materials.

Roadmap Drafting for the Law on the Juvenile Criminal Justice System (SPPA) Implementation



PUSKAPA provided the Directorate of Laws and Regulations of Bappenas with technical assistance to develop a roadmap to reinforce the Juvenile Criminal Justice System (SPPA) implementation in Indonesia. Further, PUSKAPA has established a method to develop a roadmap by conducting a literature review to identify the current state of the juvenile justice system in Indonesia and organizing a series of FGDs and interviews with relevant stakeholders. In 2021,

PUSKAPA organized FGDs to identify challenges in the SPPA implementation involving 141 participants from the central government, local governments, and CSOs from ten provinces.

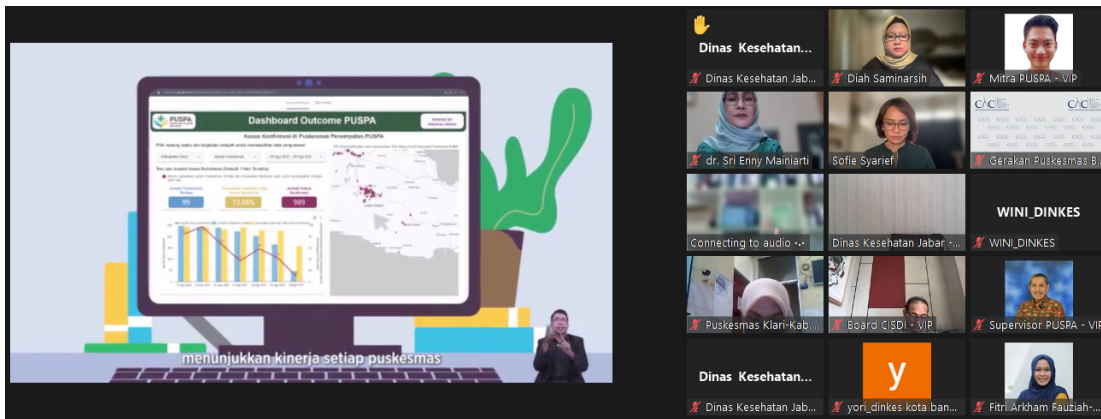
PUSKAPA has prepared SPPA Roadmap documents to be disseminated collaboratively with Bappenas in the second quarter of 2022.

PUSKAPA-CISDI Collaboration for the Primary Health Care Reinforcement



PUSKAPA has established a collaboration with the Centre for Indonesia Strategic Development Initiatives (CISDI) in the Puskesmas Responsif-Inklusif dan Masyarakat Aktif (PN PRIMA) program or Responsive-Inclusive Public Health Centres and Active Community by Pencerah Nusantara (a youth movement with the concern for improving primary health care in Indonesia).



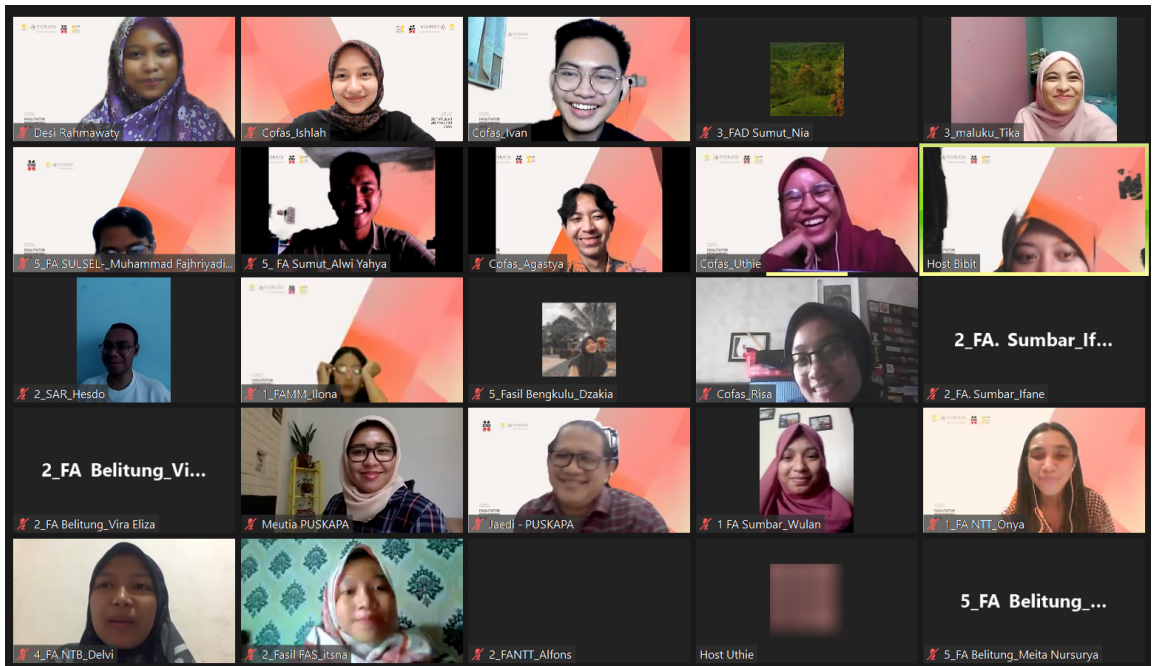
This program was prepared collaboratively by the Depok City Government, Bekasi Regency Government, and Bandung City Government under the instruction of the West Java Provincial Government. The program design process involved various local stakeholders, including the Health Office, Social Service Office, Population and Civil Registration Office, Community and Village Empowerment Service Office, as well as representatives of vulnerable groups as the target of the PN Prima program. The design process was organized from August to December 2021 through various FGDs and online/offline meetings in the three districts/cities.

The PN Prima program promoted four primary objectives. First, the COVID-19 surveillance to ensure testing, tracing, and treatment (3T) achievements are constantly optimum. Second, vaccination for vulnerable groups by prioritizing the elderly, people with comorbidities, and socially marginalized groups, i.e. the most severely affected groups due to the COVID-19 exposure. Third, the rehabilitation of the affected essential health services during the COVID-19 response, particularly chronic disease, MCH, and TB/HIV treatment services. Fourth, the ideal involvement of health cadres in assisting the public health centres (Puskesmas) to achieve their targets.

Training for the Sahabat Kapas Facilitators



As a follow-up to the Training Need Analysis (TNA) for Sahabat Kapas Facilitators, held in December 2020, PUSKAPA and Sahabat Kapas partners developed a Training of Trainer (TOT) Module. By referring to the TNA results, the TOT materials were prepared to enhance the expertise of Sahabat Kapas Facilitators in facilitation, communication, and advocacy, as well as increase their knowledge on issues of child protection, access to justice, social inclusion, civil registration, youth participation, and other related issues.

In preparing the materials, we also considered offline and online training scenarios. In an online scenario, training can be organized in Split Teams, Hybrid Teams, and Remote Teams while maintaining compliance with health protocols.

PUSKAPA and Sahabat Kapas have completed some materials and are currently developing other materials. To collect inputs, we piloted the development of two materials, now completed, including the Principles of Assisting and Engaging with Children and Access to Justice. The piloting phase, conducted in September 2021, involved child assistants of the Sekolah Advokasi Remaja network (a capacity-building medium for youth managed by Sahabat Kapas).

To encourage quality journalism and advocacy related to issues of population administration and access to its services, through mass media reporting, the Alliance of Independent Journalists (AJI), in collaboration with PUSKAPA, held a journalistic training program for local journalists with the theme "Population Administration and Poverty". This training aimed to enhance the reporting quality on the population administration system in three regions, covering the Provinces of East Java, Central Java, and South Sulawesi.

To achieve this objective, this program was executed by delivering a briefing to local journalists on issues of population administration and poverty through a series of workshops, fellowships, mentoring, and publication of the coverage results in the media.

The online workshop was organized for three days simultaneously in three clusters by inviting speakers from PUSKAPA, Bappenas, and senior journalists to share their knowledge and experiences with participants intensively on issues of population administration and poverty. After completing the workshop, participants were assigned to prepare an in-depth coverage proposal of the population administration and poverty issues. Of these proposals, AJI, together with PUSKAPA, chose the five best coverage proposals from each cluster.

Further, participants of the selected proposals would receive mentoring. The selected journalists should work on coverage tasks funded by AJI. Two to three articles produced by the best journalists in each region would be presented in a webinar session, followed by a dialogue with the local governments.

3

Learning Package: Understanding the Basic Child Protection by MOOC



The Basic Child Protection (PAD) Learning Package is aimed to introduce and apply child protection perspectives in interpreting and discussing social issues and carrying out daily professional roles. This learning package discussed various literature and scientific evidence from Indonesia and abroad, formulating the child protection framework.

Further, it is designed as an online course at the University of Indonesia (UI). The program is the result of collaboration between PUSKAPA and the Department of Criminology, Faculty of Social and Political Sciences, University of Indonesia. Despite the collaboration with the Department of Criminology, the implementation of child protection perspective in policies and practices is not limited to the aspects of law, law enforcement, judiciary, and crime prevention and management. It is also broadly applicable in various sectors of social, health, welfare, economic, political, communication, education, and other related roles.

The learning package encompasses 12 modules and 12 learning videos. Each module provides brief fundamental information and references that guide you to expand relevant reading materials independently. Each module is accompanied by a learning video which is approximately eight minutes long. The modules and videos can only be accessed by UI's MOOC (Massive Open Online Course) participants.

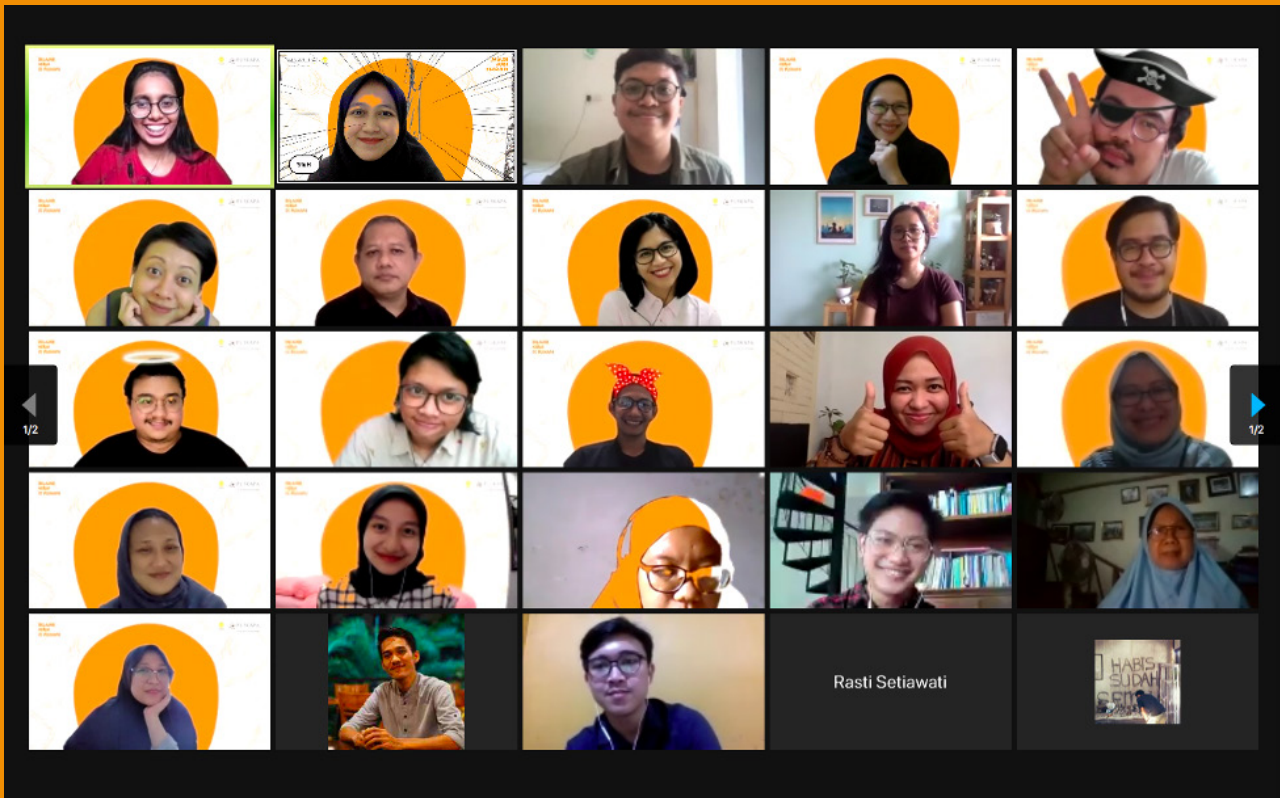
In addition to the aforementioned capacity building activities, PUSKAPA is also involved in various training activities, providing technical assistance, drafting local and national regulations, as well as providing input on various curricula related to some issues, including the protection and welfare of children and vulnerable groups, legal identity, and the budgeting of programs with a child perspective.

In 2021, it was recorded that at least 25 training and workshops were provided by PUSKAPA to increase the capacity of the government, journalists, and regional facilitators related to population administration and civil registration services, and other relevant sectors.

THIRD BATCH OF “BELAJAR KERJA DI PUSKAPA” PROGRAM

From March to June 2021, PUSKAPA held the Third Batch of internship program called *Program Belajar Kerja di PUSKAPA III*, hereinafter referred to as BKdP III Program). The BKdP III Program was held to introduce development issues, particularly child protection issues, to undergraduate students who have entered their sixth semester. The program was conducted entirely online due to the COVID-19 pandemic conditions which made it impossible to hold in-person activities.



A total of 106 potential participants from 33 universities throughout Indonesia sent their application files. Based on the results of the interview score quantitative calculation and the recruitment team discussions, four undergraduate students were selected to participate in the BKdP III Program.

For four months, those four students explored the three main pillars of PUSKAPA, namely Social Protection and Inclusion, Legal Identity and CRVS, Access to Justice, and the Trifecta (Research, Monitoring and Evaluation, Knowledge Management, and Communication).

The BKdP III Program applied a rotation system, as was the case in the previous batches. The participants studied the Pillars and the Trifecta for three weeks each and then chose one of the Pillars or the Trifecta that they wanted to learn more intensively over the last four weeks. The participants, mentors, and managers conducted a debriefing session on every last week of rotation. In this session, the participants and mentors shared what they got from their activities and reflected on their study of the Pillars and the Trifecta.

In addition, the participants also engaged in various other activities such as sharing sessions with the director, mini-workshops on advocacy, reviewing regulations, communication strategy planning, as well as discussion sessions with the alumni of BKdP I and II Programs.

Child Marriage in Indonesia

Andrea Adhi, the Lead for Social Inclusion and Protection at PUSKAPA, was invited by the SEA Today News to explain the situation of child marriage in Indonesia. They discussed how child marriage is considered a multidimensional issue, where economic, educational, environmental (rural and urban areas), and cultural factors are closely related to child marriage. The followings are the highlights of the talk show:

- In Indonesia, cases of child marriage involve girls more than boys. According to the 2019 National Socioeconomic Survey (SUSENAS) data, 1 out of 9 women was married before the age of 18 years old, while the ratio for men was 1:100.
- Child marriage leads to manifold consequences, one of which is related to the opportunity to access education. PUSKAPA's study revealed that women experiencing early marriage participate less in education than those who are married at a mature age. As a result, those women are employed in low-paid occupations, increasing the risk of living in poverty. Additionally, child marriage may cause high-risk pregnancy, which could threaten the lives of the mother and her child.

PUSKAPA collaborated with the Asia Research Centre of the University of Indonesia (ARC UI) and the Social-Political Research and Development Body (LPPSP) in a webinar series discussing how the pandemic affects social science research.

ARC UI, PUSKAPA, and LPPSP argued that the contributions of relevant research and social science to the pandemic were represented by their capacity to speak on the interests of vulnerable populations and balance the power relations among scientists, policymakers, and the community. If effective, this contribution can underlie the policies on post-pandemic handling and recovery that help equalize the opportunity to survive and develop, mitigate the bad impact of the pandemic on the people in need and anticipate this issue, and prevent the growth of new vulnerable people.

In the first series of the webinar, besides presentations from PUSKAPA, ARC UI, and LPPSP researchers constructive responses were offered by the representatives of the Government participating in the webinar. The webinar was opened by the Dean of the Faculty of Social and Political Sciences, Arie S. Soesilo, by explaining how social-political research is inseparable from policy formulation, and how actors' involvement and mobilisation of institutional resources are needed to ensure that the research is beneficial for the community.

Brown Bag Discussion

In PUSKAPA, we never stop learning and sharing knowledge. Through these Brown Bag Discussions (BBD), we invited speakers from and outside of PUSKAPA to share their new knowledge. The discussion topics were broad, from the learning about research and advocacy, recent training or workshops attended, to the new research approach; and from new publications to think pieces on current issues in Indonesia and around the globe.

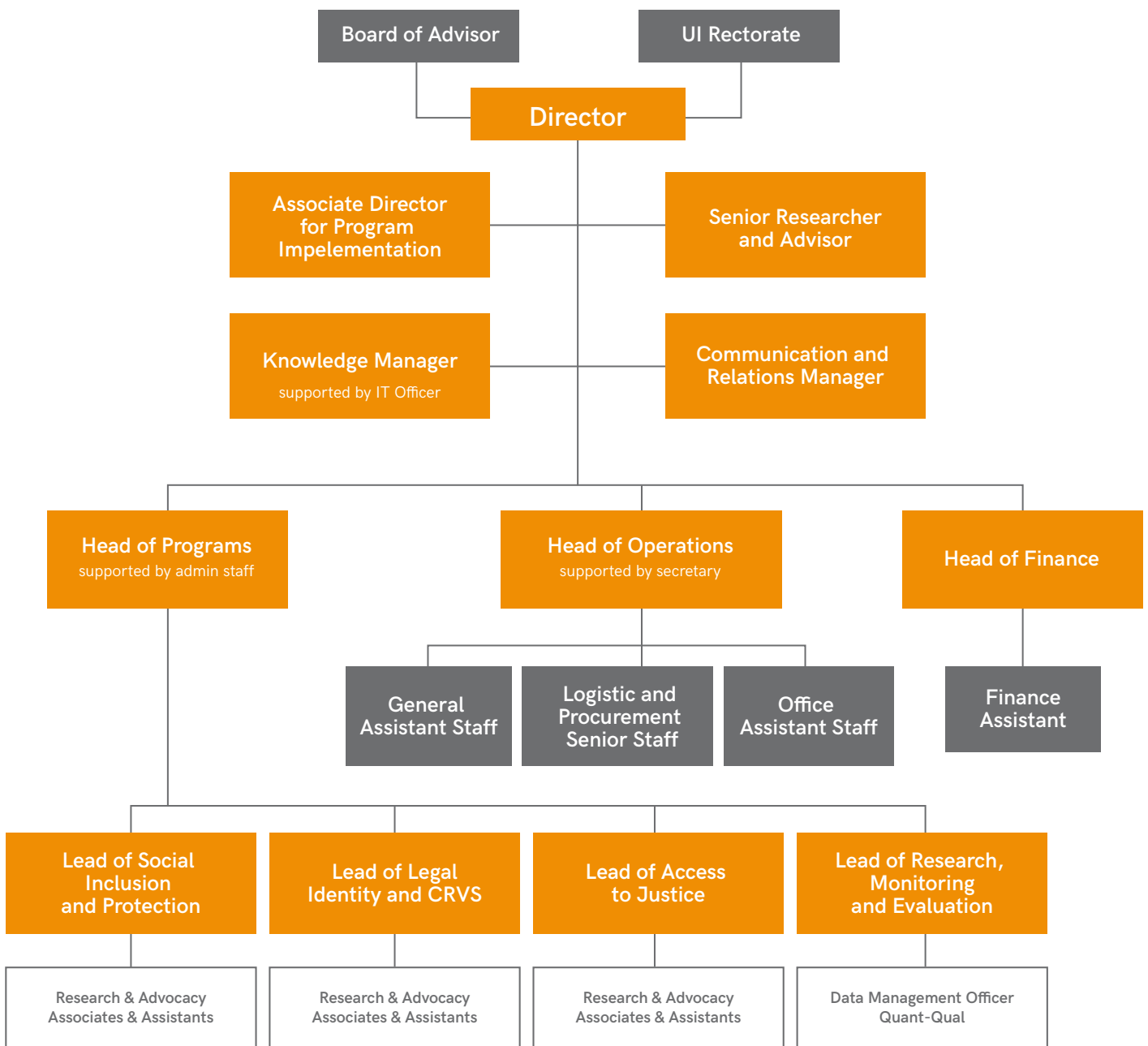
