

Research and Advocacy Project Underway in 2022

Qualitative Study: The Missing Link in Social Protection Reform Prioritization

This study aims to synthesize key lessons learned from the research and interviews to recommend advocacy priorities for civil society organizations to support a more comprehensive and inclusive social protection system in Indonesia.

Scoping Study and Mapping of Business Process Flow for Recording Birth, Death, and Cause of Death Events

Together with the National Secretariat (Seknas) of Population Administration for Development and Vital Statistics (AKPSH), PUSKAPA and Vital Strategies (VS) conducted an assessment, business process mapping of civil registration services, and management of data generated from population event recording services to encourage the availability of easy, fast, and innovative population registration and civil registration services.

Study on Strengthening Civil Registration and Vital Statistics Policies in Indonesia

This study attempts to map good practices and policy challenges in civil registration, vital statistics, and legal identity management in Indonesia against international best practices. PUSKAPA, in collaboration with Vital Strategies (VS), analyzed policies related to civil registration and vital statistics, collected primary data from ministries/agencies, and gathered key information from various literatures.

Policy Study on the Prevention and Handling of Violence in Education Units

In 2022, PUSKAPA collaborated with the Ministry of Education and Culture's Center for Character Strengthening (PUSPEKA) regarding the Optimization of Violence Prevention and Handling Policies in Education Units. PUSKAPA carries out a series of study activities and strengthening programs that refer to two key approaches. The first approach is studying and strengthening violence prevention and handling policies in education units. This approach focuses on the policy review of Minister of Education Regulation (Permendikbud) No. 82 of 2015 on the Prevention and Handling of Violence in Education Units, including preparing academic papers, problem inventory lists, and new draft regulations related to preventing and handling violence. The second approach is technical support for the implementation of programs that focus on the three sins of education (sexual violence, bullying, and intolerance).

Study on the Implementation of Child Rehabilitation in Special Development Institutions for Children (LPKA) and Social Welfare Organizations (LPKS)

In 2022, PUSKAPA, with support from Bappenas and UNICEF, conducted a qualitative study to understand the implementation of rehabilitation for children in conflict with the law in the Child Special Development Institution (LPKA) and the Social Welfare Implementation Institution (LPKS). This study is part of efforts to improve the quality of the implementation of the Child Criminal Justice System (SPPA) as outlined in the Roadmap for Strengthening SPPA 2023-2027. This study aims to provide data and evidence to Bappenas, the Ministry of Law and Human Rights, the Ministry of Social Affairs, and local governments to design effective rehabilitation services for children in conflict with the law.

Child Marriage Prevention for Sustainable Protection of Children

PUSKAPA, together with UNICEF Indonesia and the Ministry of Women's Empowerment and Child Protection (KPPPA), designed a series of activities to support the Government of Indonesia's efforts through the preparation of a policy brief that aims to unravel the issue of child marriage dispensation and what steps should be taken by various parties to prevent and overcome its adverse impact on children.

Study on Young People's Engagement with Climate and Environment (ILH) Issues

Since 2021, PUSKAPA has initiated a study on youth engagement on climate and environmental issues to understand the situation of youth engagement, identifying enabling and constraining factors and practices capable of influencing policy or social change on climate and environmental issues in the region Indonesia.

PUSKAPA collaborated with The University of Melbourne to conduct a systematic review and discursive analysis of the literature on critical studies of girls in Indonesia over the past two decades.

To strengthen the implementation of the Juvenile Justice System (SPPA), Bappenas, together with PUSKAPA and UNICEF, developed a specific strategy as outlined in the <u>Roadmap for Strengthening</u> the <u>Indonesian Juvenile Justice System (SPPA) 2023-2027</u> along with supporting instruments for monitoring and evaluation.

Citizens Seen, Recorded and Served: Final Program Report of the Strengthening Civil Registration and Vital Statistics (CRVS) Flagship Program 2015-2021 - Reflections on a Seven-Year Journey

This program final report is a synthesis of the documentation of the implementation and results of the Strengthening Civil Registration and Vital Statistics (CRVS) flagship program prepared by PUSKAPA and published jointly by Bappenas and Kolaborasi Masyarakat dan Pelayanan untuk Kesejahteraan (KOMPAK). This document aims to provide a complete picture of the journey, results, and lessons learned of the CRVS program since the initial study in 2015, program design in 2016, and phased implementation from 2016 to December 2021. The CRVS program consists of a series of approaches designed around evidence of what has hindered achieving inclusive and accountable civil registration goals.



This report was written by the Indonesia Judicial Research Society (IJRS), Institute of Criminal Justice Reform (ICJR), and PUSKAPA before the Sexual Violence Crime Law (TPKS Law) was passed. The report was jointly launched online and can be accessed by clicking the image on the left.

Research Report on the Regulation of Sexual Violence and its Accommodation in Indonesian Legislation

To ensure that the Draft Law on the Elimination of Sexual Violence (RUU PKS) can be an ideal legal product to address sexual violence and provide legal certainty to survivors, and ensure that the objectives of the formation of the PKS Bill can be appropriately conveyed in practice, IJRS, ICJR, and PUSKAPA compiled a study of the criminal provisions, procedural law, and protection of witnesses and victims in the PKS Bill.

Policy Brief on Child Marriage Prevention for the Sustainable Protection of Children

This analysis and policy proposal focuses on the importance of efforts to prevent child marriage due to pregnancy, as well as providing access to protection and governance of a continuum of services for children who experience pregnancy until after pregnancy. This policy proposal is part of the implementation of the National Strategy for the Prevention of Child Marriage (Stranas PPA) 2020-2024.

This policy brief results from the collaboration between the Child Marriage Prevention Advocacy Project and the Ministry of Women's Empowerment and Child Protection (KPPPA). PUSKAPA submitted this initial document to KPPPA in August 2022.

Technical Report: Building Inclusive Participation, Strengthening Civic Engagement - A Literature Review of Youth Participation in Indonesia

Recognizing the strategic role of young people and their potential, PUSKAPA compiled this literature review to document models, challenges, and lessons learned on youth engagement in development. This technical report results from a literature review to understand youth participation programs in Indonesia. The literature review was conducted in 2020 and included 32 documents in Indonesian and English.

Policy Note for the Corrections Law (Corrections Law)

This policy note aims to provide an overview of the substance and recommendations on the implementing regulations of the Corrections Law that focus on coaching, mentoring, and fulfilling the rights of detainees, children, and prisoners. This document is prepared as supporting material for the Legal and Human Rights Research and Development Agency for the Processing and Analysis of Pre-Policy Manuscript Studies related to the Draft Government Regulation on the Terms and Procedures for Implementing the Rights and Obligations of Prisoners, Children, and Prisoners on November 10, 2022.

Program Management Highlights

Throughout 2022, PUSKAPA went through the stages of conceptualization, design, and implementation of evidence-based programs to encourage the resolution of problems experienced by children and vulnerable groups.

Program management is inseparable from considering four aspects, namely:



The availability of problem mapping, theory of change, prioritization of interventions/approaches, and risk analysis in the program.



The availability of human resources and budget to implement the program.



The establishment of strategic relationships and partnerships to support program implementation, both with government partners, civil society organizations, and development partners.



The availability of a monitoring and evaluation framework that has been developed since the beginning of the program to document achievements and challenges in the implementation of the program, as well as inform the need for program improvement, both in terms of planning and implementation.

Inclusive and Accountable CRVS (Partnership with KOMPAK 2015-2022)

Since 2015, the CRVS program has been working with the Australia-Indonesia Government Partnership through the KOMPAK program. The program has consistently carried the message of assisting the Government of Indonesia to strengthen its Civil Registration and Vital Statistics (CRVS) system services. We believe that an inclusive, effective, and accountable Civil Registration and Vital Statistics (CRVS) system can strengthen basic services (health, education, social protection, and economic development) and ensure resource allocation is based on accurate data to improve community welfare.

Our priorities in 2022 are to ensure that resources and policies are in place to support the continuity of civil registration services at the district to village level and to establish mechanisms to utilize civil registration data for development planning. Inclusive services can also be achieved if service providers are equipped with adequate guidance and capacity to identify vulnerable groups who find it more difficult to access services. Together with KOMPAK, we also want to ensure adequate institutionalization and replication tools are in place in our assisted areas by the end of the program in 2022.

Technical Assistance to Support the Implementation of the National Strategy on Population Administration for the Vital Statistics Development - Partnership with Vital Strategies 2021-2023

2021 is the initial momentum to strengthen collaboration between PUSKAPA, Vital Strategies, and Bappenas to support the implementation of the CRVS National Strategy, especially in the aspects of birth registration, death and cause of death registration and vital statistics data processing. A series of capacity-building activities and work plans have been held to ensure the program implementation runs smoothly in 2022-2023. The collaboration agreed on three main approaches, namely: 1) mapping of policies and business processes for registering births, deaths, and recording causes of death; 2) technical support for business processes improvement for registering births, deaths, and causes of death; and 3) technical support for developing strategies for collecting, processing, and disseminating vital statistics data.

Strengthening Institutional Development through University Partnerships for the Protection and Quality of Life of Children (Partnership with CPC Learning Network-Columbia University 2009-2023)

Since its inception, PUSKAPA has maintained a strong collaboration with Columbia University. Together with the CPC Learning Network, PUSKAPA continues programs to ensure that a child's rights and quality of life approach is a development priority for the Indonesian government and that all children - especially those who are most disadvantaged - receive the rights and support they need. Through this collaboration, PUSKAPA published the Handbook of Child Participation in Indonesia.

Strategic Partnership for Child Protection (UNICEF Child Protection Partnership 2021-2023)

PUSKAPA continues the collaboration it has had since 2014 with UNICEF. Program management in this period focuses on efforts to strengthen evidence-based policies to respond to children's risk of inequality, violence, and lack of quality parenting. We see the importance of managing the evidence to inform policy recommendations and public dialog. We also see the importance of ensuring adequate frameworks in the civil registration, social welfare, and justice systems, as well as capacity-building efforts to strengthen child protection services at the national and sub-national levels.

In 2022, PUSKAPA supported the Indonesian government in developing a roadmap for the implementation of the Juvenile Justice System Law. PUSKAPA also supports civil society organizations, such as Sahabat Kapas, in capacity-building programs for young people on issues of social protection and inclusion, civil registration and vital statistics, and access to justice. PUSKAPA is also developing various skill-based capacity-building tools such as advocacy techniques, critical thinking, and guidelines for drafting policy papers.

Technical Assistance for Strengthening the Violence Prevention and Handling System in the Education Sector (Partnership with MoECristek 2021-2024)

PUSKAPA and the Ministry of Education and Culture carried out cooperation in 2022 through two collaborative approaches. The first approach is to prepare an academic review document related to violence prevention and handling policies in education units. This document contains recommendations for improving comprehensive and integrated violence prevention and handling strategies.

The second approach is through technical support from PUSKAPA to develop policy improvements related to preventing and handling violence in education units. The new draft policy includes steps that need to be taken by education units and local governments, both in terms of the need for reporting and handling mechanisms, capacity building, prevention strategies, community participation, and violence data governance.

Digital Citizenship and Gender Empowerment of Young Women (Partnership with The University of Melbourne 2021-2024)

This collaborative research project between The University of Melbourne (Unimelb) and PUSKAPA aims to systematically analyze the complexities and circumstances of girlhood in Indonesia over the past decade with a focus on the experiences of girls and young women. In 2022, the study seeks to uncover how young women's digital citizenship practices can be an important source of knowledge for their peers and formal organizations to advance gender equality goals. The research methods will be conducted through youth participatory action research (YPAR), focus group discussions (FGDs), digital diaries, and digital ethnography.

PUSKAPA and Unimelb focused on trying to answer the following research guestions:

- How do young women in Indonesia as digital citizens organize and disseminate knowledge to overcome the social, cultural, and structural barriers and challenges they face on a daily basis?
- How are they using digital tools and strategies to organize and spread knowledge on gender empowerment?

Youth Engagement on Climate and Environment Issues (2021-2023)

Various publications on the environmental crisis have highlighted the important role of Indonesian youth in environmental activism and the adoption of green lifestyles. However, few have examined their role in advocating for changes in policy, governance, or practices at the community level. In collaboration with strategic partners, PUSKAPA conducted research to comprehensively explore youth engagement in responding to and mitigating the impacts of the current climate and environmental crisis. The study highlights different ways to provide support to young people and ensure they build and sustain logical, evidence-based, and effective organizations and movements in Indonesia's climate and environmental reform plans.


The study collected data through consultations, literature reviews, focus group discussions (FGDs), key informant interviews (KIIs), and in-depth case study interviews with various young activists.

Advocacy Policy Paper on the Situation of Young People in Urban Areas for Engagement Groups Urban 20 (U20) 2022

As urbanization increases in developing countries, young, productive age groups will dominate urban areas. While Indonesian cities generally have good welfare indicators, urban areas also harbor disadvantaged groups, such as the poor, vulnerable, and marginalized-including children and youth, who are often overlooked by public policies.

PUSKAPA, in collaboration with UNICEF and MoHA, developed a policy paper for consideration by Urban 20 (U20) delegates. Inspired and informed by the 2021 study report <u>"The Situation of Children and Young People in Indonesian Cities</u>," this policy paper highlights the voices and aspirations of children and <u>young people living</u> in cities. Online consultations were conducted with young people from different cities, ages, genders, and backgrounds to understand (1) their experiences of living in cities, (2) their reflections on the challenges of living in cities, and (3) their ideas for making cities better places to live.

In order to support the implementation of Indonesia's G20 Presidency in 2022, PUSKAPA was also present as one of the speakers in the webinar <u>"A Common Framework: Towards Child-Friendly Cities Amid the COVID-19 Pandemic, Climate Crisis, and Rising Structural Inequalities"</u> in March 2022. The webinar was organized by the Ministry of Home Affairs as the host ministry for Engagement Groups U20.

From February to May 2022, PUSKAPA organized the fourth batch of the intership program, "Belajar Kerja di PUSKAPA." The BKdP IV Program was held to introduce child protection issues in particular and development issues in general to undergraduate students who have entered the sixth semester. This program is conducted entirely online due to the conditions of the COVID-19 pandemic, which do not allow face-to-face activities to be carried out.

There were 56 candidates from 14 universities across Indonesia who submitted registration files. Based on the results of the calculation of interview scores and the results of the recruitment team discussion, four people were selected to become BKdP IV participants.

For four months, the four students explored the three main pillars of PUSKAPA, namely Social Protection and Inclusion, Legal Identity and CRVS, Access to Justice, as well as the Trifecta team (Research, Monitoring and Evaluation, Knowledge Management, and Communications).

Similar to the previous batch of BKdP, the BKdP IV program also applies a rotation system, where each participant is placed in a pillar and Trifecta for three weeks each. Then, participants are given the opportunity to choose one of the pillars or Trifecta to deepen during the last four weeks of the program. Participants, mentors, and managers debrief during the final week of the rotation. At this debriefing session, participants and mentors share about the activities carried out and reflections during the pillar and Trifecta.

In addition to pillar rotation and Trifecta, participants also participated in various other activities, such as sharing sessions with the Director of PUSKAPA, mini workshops on advocacy, regulation, and communication, as well as discussion sessions with BKdP alumni batch I, II and III.



We Develop Internal Staff Capacity

During 2022, we provided six capacity-building trainings to PUSKAPA's technical and operational teams. One of them was conducted offline, and the rest were conducted online.




